  - D. INSURANCE POLICY DETAILS
  - E. DOCUMENT THE ACCIDENT SCENE AND SURROUNDING
- 4. IF THERE ARE ANY INDEPENDENT WITNESSES, GET NAME(S), PHONE NUMBERS & WITNESS ADDRESSES.
- 5. FILE AN ACCIDENT REPORT WITH THE POLICE. OBTAIN THE COMPLAINT INFORMATION SO A REPORT CAN BE REQUESTED.
- 6. IF YOU ARE INVOLVED IN A HIT & RUN ACCIDENT, CALL THE POLICE AND FILE A REPORT. THE HIT & RUN MUST BE DOCUMENTED.
- 7. REMAIN COOPERATIVE, BUT DO NOT ADMIT FAULT OR MAKE STATEMENTS THAT CAN BE USED AGAINST YOU LATER.
